#### Introduction to the workshop topic and scientific objectives

Spain and Korea are medium-size countries, with very similar populations, which first developed under strong inward-looking economic and political systems, and which have registered very successful outward-looking processes during the last thirty years or so. The strategies pursued in both cases were significantly different though. While Spain followed the regional pattern after the end of its authoritarian regime, Korea decisively entered and enjoyed the new era of globalization. For Spain, after Franco, the only internationalization option available was the *Europeanization* of the country, while Korea decisively took advantage (as it had been doing since the 1970s) of the new era of global markets.

Nowadays, however, the two countries seemed to be undergoing a substantive process of policy re-definition which paradoxically is leading both countries to a somewhat partial reversal of their respective earlier strategies. While the Republic of Korea is, since the late 1990s, working hard to regionalise a large portion of its foreign commercial relations with the recourse to Free Trade Agreements with its main commercial partners, the challenges facing Spain do not depend as much on the European Union as in the previous thirty or thirty-five years as they do on Spain itself. At times of increasing globalization, the attention in Spain is directed more towards domestic actors and how to redress internally some of its ill-fated domestic policies, while in Korea the emphasis is increasingly placed in formalizing some form of regional integration in North East Asia. An increased Asian-European dialogue on regional integration is the main consequence of Korea's new regional approach to its foreign economic policy.

The present seminar aims to analyse in comparative perspective two country studies – from completely different and distant regional scenarios – with very different strategies towards internationalization but both recording quite successful outcomes in economic, political and social terms. The organizers of this meeting believe that it should be useful to compare both countries' long-term experiences for the sake of modelling other countries' present strategies towards economic development and socio-political stability at times of increasing global interdependence.



The comparison will be carried out at three different levels, with three sets of papers, one on the Korean side and a second one on the Spanish side. A first set of papers will be dealing with long-term growth factors: how can a successful growth experience be explained? Special emphasis will be given to the role of education. A second set of papers will deal with the last economic cycle for each country, i.e., since 1999 in the case of Spain (the beginning of the Economic and Monetary Union) and since 1997 for Korea (the outbreak of the previous financial crisis in Asia). The aim of this session is to determine to what extent the policy adaptation that EMU membership and the response to the 1997 financial crisis in Asia required in Spain and South Korea respectively have better equipped both countries' policy makers to successfully confront the present worldwide economic depression. Apparently, policy reforms made the Korean people to be more market-oriented than before while in Spain policy makers, social agents and population in general all developed a deep sense of complacency due to historically unknown supportive financial conditions and accommodative monetary policies (together with fiscal windfalls associated with booms in real estate). A third set of papers will deal with Korean and Spanish firms' internationalization strategies. The global dimension of some Spanish and Korean firms is one of the most obvious features of the successful internationalization strategies pursued in our respective countries.

The workshop is conceived as a first step towards the generation of a book in a very short delay. Sessions are meanly devoted for a series of collective discussions upon pre-submitted revised papers. The intention of organizers and participants is to submit the set of papers for publication in an international peer-review journal in order to steer up the academic debate. In addition, we aim also to publish a book so that the lessons to be derived from this comparative exercise can reach public opinion and policy makers in a different format. As the publisher for this book the seminar organizers are targeting the *Routledge Studies on History and Globalization*.
