Luis García Montero, Director of Instituto Cervantes



Luis García Montero (Granada, 1958) is Professor of Spanish Literature at the University of Granada.

As a poet, author and essayist he has received, among others, the National Literature Prize (1994), the National Critics Prize (2003), the Madrid Guild of Booksellers Prize (2009), the Poets of Latin America Prize (México, 2010), the Ramón López Velarde Prize (México, 2017) and the Parallel Zero Prize (Ecuador, 2018).

He has studied the work of Spanish and Latin American authors such as Gustavo Adolfo Bécquer, Rosalía de Castro, Rafael Alberti, Federico García Lorca, Luis Rosales, Rubén Bonifaz Nuño, Francisco Ayala and José Emilio Pacheco. He is also honorary lecturer at the University of Mar del Plata (Argentina) and in 2017 was named an Honorary Citizen of Andalusia. Javier Parrondo, Director General of Casa Asia



Mr. Javier Parrondo is currently the Director General of Casa Asia, an institution of public diplomacy created in 2001 by the Ministry of Foreign Affairs and Cooperation of Spain, the regional government of Catalonia, and the City Councils of Barcelona and Madrid, aimed at fostering relations between Spain and the countries of Asia and the Pacific region, particularly among their respective civil societies. In 1999 he graduated in Law at the University Carlos III (Spain) and the following year he obtained a Diploma in Constitutional Law and Political Sciences at the Centre of Political and Constitutional Studies in Ma-

drid. Javier Parrondo joined the Spanish Foreign Service in 2003. He has served in Spain and abroad in different postings, most of them related to Asia, such as Afghanistan, Thailand, and Vietnam. He has been head of the Department of Development Cooperation with the Arab world and Asia at AECID (Spanish Agency for International Development Cooperation).

general vice-principal of the Cabinet of the President of the Higher Council of Sports (1998-2001), general vice-principal of Programs and Cultural and Scientific Agreements of the Ministry of Foreign Affairs (2001-2003) and associate to the Direction at the International Foundation and for Iberoamerica of Administration and Public Policies (FIIAPP).

He was appointed as the consul general of Spain in Melbourne, Australia (2006-2008). He was chief of Protocol of the Prime Minister José Luis Rodríguez Zapatero (2008-2012), and between 2012 and 2017 he was general consul of Spain in Edinburgh, Scotland.

Since his appointment in August 2022, he holds the position of Ambassador of Spain to the Republic of the Philippines, the Republic of Palau, the Republic of the Marshall Islands and the Federated States of Micronesia.

It is the highest Italian award given to foreigners as well as Italians living abroad. He currently serves as Philippine Ambassador to the Kingdom of Spain

Juan Fernández Trigo, Secretary of State for Ibero-America and the Caribbean and for Spanish around the World. Ministry of Foreign Affairs, European Union, and Cooperation



Juan Fernández Trigo was appointed Secretary of State for Ibero-America and the Caribbean and

Spanish in the World at the Council of Ministers held on July 20, 2021. Born in 1958 in Terrassa (Barcelona), Juan Fernández Trigo holds a degree in Law and joined the Diplomatic Service in 1986. He has been posted in the diplomatic representations of Spain in the European Union, Morocco, Vietnam, the United Nations in New York and Cuba. He has also been deputy director general of Multilateral International Economic Relations and Air, Maritime and Land Cooperation. Between 2007 and 2011 he was ambassador of Spain to Haiti and between 2011 and 2013, ambassador of Spain to Paraguay. From 2013 to 2017 he held the post of ambassador-head of Delegation of the European Union to Uruguay. From 2017 to 2018 he was an advisor in the Cabinet of the Undersecretary of Foreign Affairs and Cooperation and coordinator for the application of art. 155 of the Spanish Constitution in the Ministry of Foreign Affairs and Cooperation. From 2018 to 2020 he was Ambassador of Spain to Cuba and since November 2020 he was Chargé d'Affaires of Spain in Venezuela.

Unit at the headquarters in Madrid (2006-2008); director of the Oran center (2008-2012), director of the Technical Office of the General Secretariat (2012-2014) and of the Rabat center (2014-2019). He currently serves as Director of the Instituto Cervantes in Manila.

Daisy Lopez, Professor at the University of the Philippines Diliman and academic of the Philippine Academy of the Spanish Language (AFLE)



Daisy López was professor of Spanish and Italian at the University of the Philippines. She is the author of the collections of poems: "En la línea del horizonte" (Sevilla 2009; Barcelona, 2016), "Hermoso palabra" (Manila, 2022; Premio Abad 2022, "Chabacana ermitaña" language section), "Momentos e instantes" (New York, 2022; "VIII Premio José Rizal de las Letras Filipinas 2022") and a variety of poetic contributions that can be read in international anthologies. She works widely as a translator and also as a simultaneous interpreter for national and international conferences in the Philippines and abroad. She is a full member of the Philippine Academy of the Spanish Language.

She is also a collaborating professor at the Instituto Cervantes in Manila. She completed a Bachelor's degree in European Languages (French and Spanish) at the University of the

Philippines Diliman and a Master's degree in Teaching Spanish as a Foreign Language at the University of Valladolid. Her research focuses on the cultural and non-verbal components of Spanish language teaching and translates works of Hispanic-Filipino literature from Spanish into English and Filipino.

Marlon James Sales, Professor at the University of the Philippines Diliman



Marlon James SALES is a full professor of Hispanic Studies at the University of the Philippines at Diliman. D. in translation studies from Monash University (Australia), he specializes in translation theory, practice and history, missionary linguistics, and teaching Spanish as a foreign language. He is also a research affiliate of the Department of Comparative Literature at the University of Michigan (USA), where he worked from 2019 to 2021 as a

postdoctoral researcher and was awarded the prestigious Sawyer Research Grant from the Andrew W. Mellon Foundation. He is on the editorial board of the scientific journals Perspectives: Studies in Translation Theory and Practice (Taylor & Francis), The Journal of Literary Multilingualism (Brill) and Traduction et Langues (University of Oran, Algeria).

María Dolores Elizalde, Scientific Researcher at the CSIC (Institute of History, Centre for Human and Social Sciences, The Spanish National Research Council)



María Dolores Elizalde is Scientific Researcher at the Institute of History, Spanish National Research Council (CSIC), in Madrid, Spain. She received her doctorate in History from the Universidad Complutense de Madrid. She has been Research Scholar at the London School of Economics and Political Sciences (LSE) and Visiting Fellow at the Université de Paris 1-Sorbonne, the School of Oriental and African Studies (SOAS), University of London, and the School of Pacific and Asian Studies, University of Hawaii. She is a specialist in the history of interna-

tional relations, empires, and colonial and postcolonial processes in Asia and the Pacific, with a particular interest in the Philippines, and the 19th century. Her last publications are:

She has several publications in English and Spanish in this field, including a monograph that focuses on works from the first half of the 20th century.

Rocío Ortuño Casanova is a Researcher at the Alcalá University (2022-2024) and teacher at the Amberes University and she worked between 2013 and 2016 at the University of the Philippines (Diliman). She is specialized in literary and cultural relations between the Philippines and Spain. On this topic, she has co-edited two books with Axel Gasquet: *Transnational Philippines* (pending publication), and *The*

challenge of modernity in Hispanic-Philippine literature (Brill 2022), adding that she has published several articles on the topic. She is the creator of the portal on Philippine literature in Spanish at the Virtual Library Miguel de Cervantes and of the database "Filiteratura". She has also coordinated several projects in which Philippine universities have participated, such as the project "Strengthening Digital Research at the UP system: digitization of rare periodicals and training in Digital Humanities" with the University of the Philippines (Diliman), financed by the "Agencia Flamenca de Cooperación Académica", or the Erasmus+ project with the participation of the Ateneo de Manila "DigiPhiLit" university on Hispano-Filipino literature and digital humanities.

Rafael Rodríguez Ponga, President of the Spanish Association of Studies on the Pacific (AEEP), and Rector of the Abate Oliba CEU University



Rafael Rodríguez-Ponga Salamanca (Madrid, 1960) is the rector of the "Universitat Abat Oliba CEU" (Barcelona), where he is professor of Spanish Language. He holds a PhD in Philology from the "Universidad Complutense". He is the president of the Spanish Association of Pacific

Studies and of the International Platform for Cooperation and Migration. He was secretary general of the "Instituto Cervantes" (2012-18). He has published studies on language contact and cultural issues, with special attention to the Philippines and Marianas. **Original**
